23/21 **Declarations of interest:** Cllr Ranson; aspects of Langore Green.

23/22 **Minutes:** Minutes of meeting 4/5/23 were carried over to next meeting.

23/23 **Public representation;** No public were present.

23/24 **Correspondence:** Public Spaces Protection Order: happy to remain as is. 2 Code of Conduct Complaints made, neither upheld.
