Scott thanked the Council for inviting him and said he had had an enjoyable first 20 weeks as our Member of Parliament. The whips had been friendly for the first few weeks. He receives some 50 letters per week from constituents and has one staff member in Westminster and the rest of the team local. He has approx 900 casework files. His maiden speech immediately followed Boris Johnson and was well received. Scott explained he holds surgeries in each of the 6 major towns visiting each every 6 weeks. He believes in being honest and if he is unable to help he will say so. Scott will be proposing his first piece of legislation next week, a bill to give Parish and Town Councils the ability to set speed limits locally. He believes in devolution and giving power to the Parishes. Scott explained that he normally uses the train to get to London and travels 2<sup>nd</sup> class. He supports the need for improved rail links. Scott finished by saying North Cornwall is a great place to do business and was pushing it whenever he could making particular reference to Bude computer programming centre.
